

## TERMS OF REFERENCE

Development of a Capacity building strategy and training modules on ABS and their integration into a training manual in Cameroon

Reference in PTA 2025: activity 34

## 1. Context

In accordance with the obligations regarding access and benefit-sharing, the States Parties to the Convention on Biological Diversity (CBD) adopted in October 2010 the Nagoya Protocol on Access to Genetic Resources (GR) and the Fair and Equitable Sharing of Benefits Arising from their Utilization (ABS), that entered into effective in 2014.

In 2016, Cameroon ratified the Nagoya Protocol on ABS and in 2021 adopted Law No. 2021/014 of July 9, 2021 governing access to genetic resources, their derivatives, associated traditional knowledge (CTa) and the fair and equitable sharing of benefits arising from their use; and in 2023, the Decree No. 2023/07526 of October 6, 2023 setting out the modalities for the application of the said law.

In order to promote its implementation, the Nagoya Protocol on ABS places emphasis on capacity building.

At COP15 in December 2022, 192 countries adopted the Kunming-Montreal Global Biodiversity Framework (KMBF), which includes four goals and 23 targets to halt and reverse biodiversity loss by 2030.

Target 13 of this new global framework, among others, commits CBD parties to take effective legal, policy, administrative and capacity-building measures at all levels to

increase the sharing of benefits from genetic resources, digital sequence information and traditional knowledge.

As part of the efforts to implement the ABS framework of Cameroon, a capacity building strategy as well as training modules had been initiated within the framework of the project "A bottom up approach to ABS: community level capacity development for successful engagement in ABS value chains in Cameroon".

In 2023, the project entitled "Support to Nagoya Protocol implementation, research, and development, on Biodiversity value chain for smallholders in the South-West and Far North Regions of Cameroon" was approved by the Global Environment Facility (GEF).

Component 2 of the project focuses on capacity building and awareness-raising among key stakeholders for the implementation of the national ABS framework. The implementation activities of this component include the development of a capacity building strategy and training modules on ABS and their integration into a training manual in Cameroon.

The Ministry of the Environment, Nature Protection and Sustainable Development wishes to update this existing strategy and training modules in light of the developments contained in Cameroon's new ABS law, ABS strategy and the new Kunming-Montreal global biodiversity framework.

It is this context which justifies the formulation of these terms of reference.

# 2. Objective

The overall objective of the work is to develop a capacity building strategy and training modules on ABS. This strategy will cover a period of 5 years starting in early 2026 and will address all dimensions of ABS (genetic resources, associated traditional knowledge, and DSI).

## 3. Expected results

At the end of the assignment, the consultant is expected to produce a capacity building strategy document and training modules on ABS intended for key stakeholders, including staff from relevant institutions involved, indigenous populations and local communities, civil society organizations, researchers, and the private sector.

# 4. Methodology

The methodological approach that will be validated by the project team will take into account the following steps:

# 4.1. Preparation

The expert will work closely with the project team. To this end, before the start of the mission, he or she will have to develop a methodological approach to achieve the desired objective. This methodological approach will be adopted during a scoping meeting and will include a clear timing for the submission of deliverables.

## 4.2. Literature review

The expert will conduct a literature review on the capacity building strategy and training modules initiated within the framework of the project "A bottom up approach to ABS: community level capacity development for successful engagement in ABS value chains in Cameroon", the new ABS strategy of Cameroon, the new global biodiversity framework, the ABS Law and its implementing texts, and all other relevant resources, the training modules developed within the framework of the GIZ BioInnovation Africa II Project.

### 4.3. Stakeholder consultation

The consultant will:

- organize consultation meetings with representatives of indigenous populations and local communities, private sector stakeholders, scientific research, and administrations that are members of the National ABS Committee, to make an assessment of capacity building needs;
- prepare a report on the capacity building needs analysis.

# 4.4. Strategy development

The strategy will cover the following elements:

- The state of art, the context of capacity building within the framework of ABS in Cameroon and the experiences learned;
- The proposed capacity building strategy, indicating the goal, strategic objectives, strategic priorities, and expected results;
- The action plan for implementing the strategy including potential partnerships and monitoring and evaluation mechanisms

# 4.5. Development of training modules

The training modules should be designed to cover all areas of ABS, taking into account developments linked to Cameroon's new ABS strategy and the new Kunming-Montreal global biodiversity framework.

The training modules should take into account the specific needs of key stakeholders, including relevant institutions involved, indigenous peoples and local communities, civil society organizations, researchers, and the private sector.
