

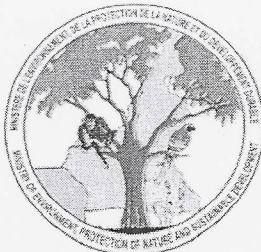

RELATED TO THE RECRUITMENT OF FIVE (05) CONSULTANTS FOR THE PROJECT:

"GEF Project ID 10850: Support to Nagoya protocol implementation, research and development, on Biodiversity value chain for small holders in the South-West and Far North Regions of Cameroon."

PROJECT DESCRIPTION

The Nagoya Protocol on Access to Genetic Resources and the Fair and Equitable Sharing of Benefits Arising from their Utilization is an international agreement that aims to ensure that the benefits arising from the use of genetic resources are shared fairly and equitably with the countries and communities that provide them.

The Project titled "Support to Nagoya Protocol Implementation, Research and Development, on Biodiversity Value Chain for Small Holders in the South West and Far North Regions of Cameroon" is a 3-year project funded by the Global Environment Facility (GEF), Executed by MINEPDED and implemented by the United Nations Environment Programme (UNEP).

The project aims to support the operationalization of the ABS national framework in Cameroon, by enabling access to genetic resources and associated traditional knowledge that accrues tangible national and local economic benefits from their commercial utilization in a fair, equitable, and sustainable manner.

The project will focus on two Regions in Cameroon: the South West Region, which is home to a rich diversity of plant and animal life, and the Far North Region, which is home to a number of Indigenous communities with traditional knowledge of the use of biological resources. The project will work with a variety of stakeholders, including government agencies, research institutions, businesses, and Indigenous communities to develop and implement a number of activities, including:

- capacity building for stakeholders on ABS to facilitate the implementation of the Nagoya Protocol on Access and Benefit Sharing;
- development of tools and resources to support ABS implementation;
- promotion of public awareness and engagement on ABS;
- research on genetic resources derived from the biodiversity of Cameroon and their economic potential;
- promotion of biodiversity-based value chains that are compliant to the Nagoya Protocol.

The project is expected to contribute to the sustainable management of biodiversity in Cameroon, the fair and equitable sharing of benefits from the use of genetic resources, and the economic development of local communities.

This shall be achieved through the implementation of 3 Components, namely:

- **component 1:** Implementation of the ABS legislative, regulatory, policy and institutional framework;
- **component 2:** Capacity building and awareness raising of key stakeholders for enforcement of the National ABS Framework;
- **component 3:** Piloting ABS agreements that demonstrate best practices of PIC, MAT and ABS permit, including the effective fair and equitable sharing of benefits.

The project will demonstrate the potential benefits of genetic resources and associated traditional knowledge for four plant species *Irvingia wombolu*, *Monodora myristica*, *Balanites aegyptiaca*, and *Accacia nilotica*. The activities shall be carried out in three administrative divisions of the South-West Region (Manyu, Kupe-Muanenguba and Meme), and one of the Far North Region (Mayo Kani).

For this project, we are looking for five consultants to execute the following tasks:

- 1- elaboration of a methodological guide for taking into account the value of genetic resources and ABS in the elaboration of management plans for protected areas;
- 2- development of a capacity-building strategy and training modules on ABS and their integration into a training manual in Cameroon;
- 3- elaboration of a report and guidelines to promote protected areas as a core drivers of nature-based tourism in the South-West and Far-North Regions of Cameroon, in particular on themes related to genetic resources, associated traditional knowledge and digital sequencing information;
- 4- development and validation of a business model for local biodiversity women-led value chain targeting key products in Manyu, Mayo Kani, Kupé Muanenguba and Meme Divisions;
- 5- assessment of knowledge, attitude, and practice towards Access and Benefit Sharing (ABS) among key stakeholders' groups in Cameroon.

In this light, the Minister of the Environment, Protection of Nature and Sustainable Development invites all interested consultants to express their interest by providing the information demonstrating that they are competent to carry out the above-mentioned position as ABS project Staff (qualifications, experience in similar positions, Curriculum Vitae, Cover Letter, Contracts, Various Documentation, etc.).
